PAYMENT AND CONTRACTING TERMS

▶ **1st PAYMENT:** For the Reservation of floorspace to be accepted, this Participation Form, duly filled in and signed, must be accompanied by a deposit of 25% for the amount corresponding to the area requested (including VAT), with a minimum of €360 set. ▶ **2nd PAYMENT:** Unless indicated otherwise, the exhibitor must **pay the amount outstanding** of the total sum corresponding to the floor space and services contracted (including VAT), having deducted the quantities paid to account, **prior to 2 November 2022**, 15 days before the commencement of activities.

▶ **IMPORTANT:** Services contracted at the last moment must be paid for when they are contracted. No location will be offered until the first payment has been made. In the event that the 2nd payment is not made within the time limits indicated, the exhibitor will lose all rights to the reserved spaces, as well as the sums paid

OTHER CONDITIONS FOR PARTICIPATION

1. ADMISSION AND ACCEPTANCE OF REGULATIONS

1.1. Exhibitors, through their mere registration, accept the General Regulations of the Foundation, which are available at www.feiragalicia.com/normativa, as well as the Specific Regulations for each trade fair, and any other provision issued by the Event Management

1.2. The admission of applications and the assignation of floor space are the sole competence of the Management of the ABANCA International Exhibition Centre of Galicia

1.3. The Organisation may reject a request if the products are not in line with the theme of the event, or are not listed in the classification.

2. LOCATION, DATES AND OPENING TIMES

2.1. The 1st edition of the "SEDEXPO, International Security, Defence and Emergency Fair" will be held in the ABANCA International Exhibition Centre of Galicia from 17 to 19 November 2022, between 10:00 a 19:00 h, uninterruptedly.

2.2. Exhibitors will have access to the stands from 9 AM until 7:30 PM. The organisation recommend that stands be manned until the premises is vacated.

2.3. The exhibitor will be obliged to occupy and remain at the stand, as well as to display the products related with the theme of the event, throughout the entire duration of the same.

3. CONTRACTING OF SPACE/SERVICES AND PAYMENT METHOD

3.1. The floor space and services are contracted in accordance with the indications, payment methods and deadlines that appear in this Participation Form.

3.2. The closing date for contracting floor space is 18 October 2022, thirty days prior to the commencement of activities.

3.3. The closing date for contracting all the services is 27 October 2022, fifteen days before the mounting of the even commences. A surcharge of 20% will be applied to any services requested after the deadline date, with the Foundation reserving the right to admit any such request. The cancellation of a service after 7 November 2022, within the 10 days prior to the commencement of the Event, well until the payment of 40% on the tariff for said service.

3.4. All invoices issued to the Exhibited by the Foundation will include the VAT currently in force, or any other tax which may be applicable at any time.

4. PREFERENCE IN THE AWARDING OF SPACES

4.1. Companies will be able to access the space allocation process once this Participation Form has been submitted, along with proof of the required payment.

4.2. The allocation of spaces will be the exclusive competence of the Organisation, which will, as far as possible, take into account the characteristics of the space contracted, but also the possible sectorisation of the event, the distribution and balance between spaces, and in general, any other circumstances that affect the improvement of the fair.

4.3. The Organisation reserves the right to modify the space allocated to an exhibitor and to assign it another of similar characteristics, if exceptionally required, without the exhibitor being entitled to any compensation.

5. ACCREDITATION, PARKING PASSES AND INVITATIONS

5.1. Exhibitors will be sent free accreditation, parking passes and invitations, at an amount proportional to the m² of floor space contracted.

6. OPENING HOURS FOR ASSEMBLY, DISMOUNTING AND REMOVAL OF MERCHANDISE

- Assembly of designer stand: 11/11/2022 to 16/11/2022 fom 09:00 to 19:00 h.

- Intake of merchandise and decoration of stands: 16/11/2022 from 09:00 to 19:00 h.

- Packaging and shipping of merchandise: 19/11/2022 from 22:00 a 24:00 h. and 21-22/11/2022 from 09:00 to 19:00 h.

- As of 18:00 h. on 16/11/2022, vehicles will not be allowed to enter the pavilions

- Exhibitors may find more detailed information regarding the regulations on mounting and is installation of spaces, intake/shipping of merchandise, etc. in the General Regulations.

7. REGULATIONS FOR ASSEMBLING DESIGNER SPACES OR STANDS

7.1. Those companies opting for the free-design construction of their stand must send the PROJECT to the Foundation's Technical Services Department [Dirección de Servicios Técnicos] before the 18 October 2022 thirty days before the commencement of the event.

7.2. The assembly fees given in the current list of charges (covering the electrical inspection, consumption, uses, etc.) are already included in the tariff applied to those exhibitors participating with a designer stand.

7.3. Exhibitors can find more detailed information regarding the regulations on the mounting and installation of spaces, the carrying out electrical installations etc. in the Foundation's General Regulations.

8. OFFICIAL EVENT CATALOGUE

8.1. Once the Participation Form has been received, the Organisation will send each exhibitor the form for inclusion into the Official Event Catalogue.

8.2. Failure to receive this form, duly completed by the exhibitor in line with instructions given therein, will authorise the Organisation to make use of the data appearing Participation Form and included the same in the Official Event Catalogue.

9. PERMITS AND LICENSES

9.1. The Exhibitor must have the licenses or permits legally required for the possession, display or use by the same of any type of property subject to display in the space allocated, and must submit in due time and form the documentation required by the Organisation in cases of actual armament or defence material or life-sized replicas.

9.2. The exhibitor authorises the total or partial reproduction of those images and videos of exhibited products that the Organisation may require to promote the event.

10. INSURANCE, SECURITY OF PREMISES AND EXEMPTION FROM LIABILITY

10.1. The exhibitor must take out a civil liability policy covering attendance at fairs for any possible damage to a third party.

10.2. In no case may exhibitors make any claim against the institution (organiser) or the employees thereof, for any damage caused to third parties, or for the loss of or damage to material and objects on the stand.

10.3. Exhibitors can obtain more detailed information in the General Regulations of the Foundation.
